Correction to DeVietti et al.

In the article "Previous Experience Disrupts Atropine-Induced Stereotyped 'Trapping' in Rats" by Terry L. DeVietti, Sergio M. Pellis, Vivien C. Pellis, and Philip Teitelbaum (*Behavioral Neuroscience*, 1985, Vol. 99, No. 6, pp. 1128–1141), three lines were erroneously repeated. In the first paragraph on p. 1138, the third sentence should read as follows: Further, at the high doses that result in stereotypic trapping there are reliable changes in both cortical and hippocampal activity (Schallert et al., 1980; Shoham, Chen, DeVietti, & Teitelbaum, 1985; Vanderwolf, 1975).
